

Defining Citizenship Education

- Citizenship Education is teaching or promoting those skills that help people to become active and responsible citizens in a society.
- These skills help the person to understand Rule of law, democratic process, Critical thinking, Personal role with rights and responsibilities.
- Citizenship education is a way of providing background knowledge and skills to the young generation so that they may understand their role in future for a democratic and tolerant society

Defining Citizenship Education

- Citizenship education gives people the knowledge and skills to understand, challenge and engage with democratic society including politics, the media, civil society, the economy and the law.
- Democracies need active, informed and responsible citizens - citizens who are willing and able to take responsibility for themselves and their communities and contribute to the political process.
