### Human Rights - Theme

- Human Rights are a set of principles concerned with equality and fairness.
- They provide us, the freedom to make choices about our lives and to develop our potential as human beings
- ► They are about living a life free from fear, harassment or discrimination.
- ► They are universal in nature: all rights for every one across the globe



- ▶ Human rights are the basic rights and freedoms from birth until death.
- These basic rights are based on <u>shared values</u> like, dignity, fairness, equality, respect and independence
- International and National Laws define and protect these values
- Definition

Human rights include the right to life and liberty, freedom from slavery and torture, freedom of opinion and expression, the right to work and education, and many more. Everyone is entitled to these rights, without discrimination

# UN Charter and International Human Rights Law

- ► Charter of the United Nations in 1945
- ▶ Universal Declaration of Human Rights(UDHR)- 1948
- International human rights law by United Nation and fundamental - a comprehensive body of human rights
- ► The United Nations has defined a broad range of internationally accepted rights, including civil, cultural, economic, political and social rights. It has also established mechanisms to promote and protect these rights and to assist states in carrying out their responsibilities.

## Five Categories of Human Rights

#### Civil Rights

The rights to be treated as an equal to anyone in society.

#### Political Rights

The right to vote, to freedom of speech and to obtain information

#### ► Economic Rights

The right to participate in an economy that benefits all; and to desirable work

#### Social Rights

The right to education, health care, food, clothing, shelter and social security

#### Cultural Rights

The right to freedom of religion; and to speak the language; and practice the culture of one's choice



## Human Rights and Constitution of Pakistan

- ▶ The constitution of Pakistan (1972) prvides fundamental rights, which are
- Freedom of Speech
- Freedom of thoughts
- Freedom of information
- Freedom of press
- Right to Education.
  - Article 25-A of Constitution of Pakistan, states "the state shall Provide free and compulsory education to all children of age 5-16 years"



## Current Human Rights Issue in Pakistan

#### Some issues are

- ▶ **Religious Freedom**: Misuse of some laws
- ▶ Freedom of Expression and Attacks on Civil Society: A civil society is a community of citizens linked by common interests, they face attacks and threats, self-censorship, Controlling media
- Women's and Girls' Rights
  - Child marriage, Violence against women and girls, honor killings, acid attacks, domestic violence, and forced marriages
- Children's rights. Child marriage, Child Labour, Lack of educational facilities.
- Rights of Weaker Communities; harassed, Less Protected, ignored
- ► Terrorism, Counterterrism and Law Enforcement Abuses
